Failure to Implement...

- Impacts equity and threatened communities
- Impacts to the natural and built environment
- Public health
- Decreased Trust. Public has memory! Digital age, failure is not forgotten.
- Snowball effect of issues that may not even be related compounding on each other and driving increased conflict and frustration



Hazards to Successful Implementation


- The 24 hour news cycle and social media have driven public involvement into an entirely new space...
- Public Demand... People want to drive influence to get things done. They demand dialogue and action.
- There are competing interested for limited funding and resources.





Why the Failure to Implement?

- Decision makers that fear bad press, bad social media, increased conflict and litigation.
- Increased pressure to deliver quickly (Executive Order 13807)
- Aged Infrastructure and Competition for Resources and Funding
- Revolving door of agency leadership: Key people in "acting" roles or on extended "details"
- Disconnect between Policy, Program & Project levels of multiple agencies
- Failure to enforce the law and hold offenders accountable
- Silver Tsunami (massive potential for retirement and limited experience in replacements)









Some of the Things we can do today...

- Realize that failure to implement has broad impacts for everyone.
- Define it.
- Learn from those that do it well!
- Communicate the attributes, stories and examples of good implementation.



Facebook Live - The Why

- Expand the reach of engagement
- Engage in a personable way that humanizes the Department
- Increase access to decision-making
- Improve transparency
- Show the work being done



Facebook Live - How

- Equipment
 - Cell Phone
 - Gimbal
 - Microphone
 - Expandable to studio-level production



Facebook Live - What

- Public Meetings
 - Use existing materials developed for public meeting
 - Break away to walk people through open house
 - Engage in comments during live stream and after



Facebook Live - What

- In the field
 - Focus on project or activity
 - Share major talking points
 - Consider including subject matter expert as guest
 - Engage in comments during live stream and after



Facebook Live - Results

- I-84 Open House
 - 8.2K reach
 - ~4% retention
 - \$43 boost 6.5K reach increase
- I-84 bridge project
 - 21K reach
 - ~4% retention
 - \$100 boost 16.4K reach increase



Facebook Live - Takeaways

- Equipment and connection impact production quality
- Engagement during livestream is low, benefit is afterwards
- Boost, boost, boost
- Low barrier of entry, can get complicated if you want it to
- We're learning as we go
