**West Davis Corridor | Utah Department of Transportation (2021 – ongoing)** West Davis is a new 16-mile, 4-lane divided highway project that required extensive public involvement. To manage this critical component, The Langdon Group was hired to coordinate all stakeholder and city communications. She also oversaw the development of a business promotion program, managed public presentations and events, and coordinated web, media, social media, and telephone hotline outreach efforts. Antelope Effluent Pipeline | North Davis Sewer District /Syracuse Utah (2021 – ongoing) North Davis Sewer District is currently undertaking a significant project to construct a 6-mile pipeline that will relocate its current outfall from Farmington Bay to Guilbert Bay. As part of the project team, Jeni is playing a crucial role in assisting with website updates and creating visual assets to ensure that stakeholders and the broader public are kept informed of the project's progress.

Clinton 1300 North & 2000 West Intersection Reconstruction | Clinton City (2021 –2022) The City of Clinton has reconstructed the intersection of 1300 North and 2000 West. The project involved widening the intersection to include turn lanes. As the lead public involvement specialist on this project, Jeni played a vital role in ensuring that the community was informed and engaged throughout the construction process. Clinton/West Point 800 North Road Reconstruction | Clinton & West Point City /Clinton Utah (2021) Clinton and West Point City collaborated on a road reconstruction project on 800 North, which involved widening the road and adding important pedestrian infrastructure such as sidewalks, curb, and gutter. As a public involvement specialist, Jeni facilitated communication and engagement between the project stakeholders and city officials. She coordinated with residents and community leaders to gather feedback and address concerns throughout the project's lifecycle. In addition to coordinating stakeholder engagement, Jeni managed the project hotline and email, and carefully documented all stakeholder interactions in a comprehensive project database. This helped to ensure that all concerns and questions were properly addressed and that stakeholders were kept informed of the project's progress and impacts.

# Utah Division of Forestry Fire and State Lands – Weber River Facilitation (2020 – Present)

This effort follows two landmark state supreme court decisions related to public access to the river, which has raised important issues around navigability, state sovereignty, public access, and waterway management. Jeni and her team are working closely with state officials, community groups, and other stakeholders to develop effective engagement strategies, facilitate productive dialogue and collaboration, and ensure that all parties have a meaningful voice in shaping the future of the Weber River. Through their work, they are helping to build trust, foster understanding, and create a shared vision for sustainable and equitable waterway management in the region.

**U.S. Forest Service (USFS) – Manti-La Sal Forest Plan Revision, Price, Utah (2017 – Present)** Region 4 of the USFS has enlisted the support of Sundance Consulting and The Langdon Group, led by Dan Adams, to assist with the development of effective outreach strategies for a series of forest plan revisions. The Manti-La Sal National Forest is one of the forests that will benefit from this effort. Jeni and her team are specifically focused on providing guidance and support for tribal outreach and engagement. Jeni is leveraging her expertise in public involvement, community engagement, and conflict resolution to help develop outreach strategies that are tailored to the needs and interests of tribal communities.
